### **BBA /BCA Course Eligibility, Age Limit and Basis of Admission**

Bachelor of Business Administration (BBA) and Bachelor of Computer Applications (BCA) are three year Degree Courses having Semester system of examination spread over six semesters under Self-Financing scheme.

**The distribution of seats for the courses is as under:**

Subsidized seats	25
Non-Subsidized seats	5

## **Eligibility**

Plus two examinations in any discipline under 10+2 scheme or any other examination equivalent thereto, of Board/University established by law in India with at least 40% marks (35% marks for SC/ST category). **Courses will start from session 2021-2022 only if 75% of the seats are filled.**

### **Age Limit:**

Maximum age limit for admission to BBA/BCA course is 21 years for the general category, 24 years for SC/ST category and 23 years for the girl candidates as on 1<sup>st</sup> July of the year concerned. The Vice Chancellor may permit age relaxation upto maximum of three months.

## **BASIS OF ADMISSION**

### **Subsidized Seats:**

The admission to BBA/BCA will be purely on the basis of merit obtained in 10+2 class from CBSE / ICSE / HP Board of School Education or any other equivalent board recognized by Govt. of India.

### **Non-Subsidized Seats:**

This scheme admits students as per the merit examination. The candidate seeking admission under non-subsidized category must submit his/her application on a plain paper with the Co coordinator. After filling the seats in the subsidized category, top 10 candidates in the merit list who have applied separately for the non- subsidized category will be admitted in this category.

In addition to the eligibility conditions mentioned above(under subsidized category), NRIs/NRI Sponsored/ Foreign nationals shall be required to submit along with the application form, the following documents as may be applicable for the category of their candidature.

A. Proof of nationality in case of Foreign Nationals.

B. Proof of their status in the case of NRI's. For this purpose, either of the following documents shall be considered as a proof.

- (i) Copy of Non-resident card/Employment card issued by the employer.
- (ii) Photocopy of the immigration card/employment VISA entry on the passport along with details of the passport.

(iii) Certificate issued by the Indian Embassy/High Commission in the country where NRI is residing.

C. Certificate of sponsorship from NRI in the case of a sponsored candidate, along with proof of NRI status of the sponsor required under para (B)

D. Photocopy of the latest assessment order of the Income-tax authorities in India and the Permanent Account number (PAN) of the sponsor issued by the Income Tax Department.

E. Two self addressed envelopes of size 28X13 cm bearing stamps for Rs.6 or in the case of Foreign addressee stamps of required amount should be affixed by the applicant. Admission to the courses except for seats reserved for NRI's/NRI sponsored and foreign students shall be subject to the following conditions:

(A) 15% and 7.5% seats shall be reserved for Scheduled Caste and Scheduled Tribe candidates respectively, who have passed their qualifying examination from H.P. Board of School Education, or any other school located within the territorial jurisdiction of Himachal Pradesh affiliated to any other Education Board e.g. CBSE or ICSE board etc. However, reservation of seats will be governed by notification of the Government from time to time.

(B) The remaining 77.5% seats shall be filled as under:

(i) 25% of the seats for admission to the course shall be open for all the candidates irrespective of the institution from which they have passed their qualifying examination.

(ii) 75% of seats shall be filled out of the candidates who have passed their qualifying examination from H.P. Board of School Education or any other school located within territorial jurisdiction of Himachal Pradesh affiliated to any other Education Board e.g. CBSE or ICSE Board etc. subject to the following reservation:

(a) 5% of all seats shall be reserved for outstanding sportsmen.

(b) 5% of the seats shall be reserved for the outstanding cultural activists.

(c) 3% of the seats shall be reserved for physically handicapped candidates.

(d) Provided that the minimum eligibility for admission to the course in Case of SC/ST will be 5% lower than the eligibility conditions for other candidates.

The admission to these reserved seats as stated at (a), (b) & (c) to para (ii) of clause (B) above shall be made as per procedure/rules approved by the Executive Council from time to time.

## **RAGGING IS A PUNISHABLE OFFENCE UNDER LAW**

Students are informed that under the orders of the Hon'ble Supreme Court of India as well as Hon'ble High Court of Himachal Pradesh and The Himachal Pradesh University, Ragging in Educational Institutions is strictly banned.

- No student shall indulge in ragging in any form, within or outside the premises of college.
- Any student found guilty of ragging will be punished with imprisonment for a term which may extend to three years or with fine which may extend to rupees fifty thousand or with both.
- If any incident of ragging comes to the notice of the authority, the concerned student shall be given liberty to explain and if his/her explanation is not found satisfactory, the authority would expel him/her from the institution.
- Any student if on prima facie evidence is found guilty will be suspended/ expelled from the College/Institution.
- Expelled student will not be admitted in any other Institution for a period of three years from the date of order of such expulsion.
